Fast, Reliable, and “Greener” Commissions

If you don't already have your commissions deposited electronically, consider this:

Electronic Funds Transfer (EFT) is faster, more reliable, and kinder to the environment than a paper check!

Compare EFT to paper checks:

	EFT	Paper Check
Accessibility	Deposit is automatic and direct to your bank, even if you are out of town. Funds are available as soon as the deposit hits your checking account.	Wait for the check to be delivered; then drive to the bank, stand in line, make the deposit, and wait for the funds to clear.
Reliability	Multiple levels of security. Increased confidentiality.	Passes through many hands. Increased risk of stolen or lost checks, and forged signatures.
Environmental Concerns	Kind to the environment. Saves paper/trees. Saves fuel/energy.	Uses paper/trees for printing and mailing. Uses fuel/energy for delivery – to you and to bank

- Sign-up for EFT is easy; just complete the attached [enrollment form](#) and return it to us at the address or fax listed on the form.
- Online enrollment is available for producers of fixed life insurance and fixed annuity business. Logon to pro.genworth.com then click the Commissions or EFT link and complete the online registration... your fastest and greenest method to sign-up!
- We process online registrations in one business day; paper requests, received in good order, are processed within two business days. EFT payments will start with the next commission cycle.

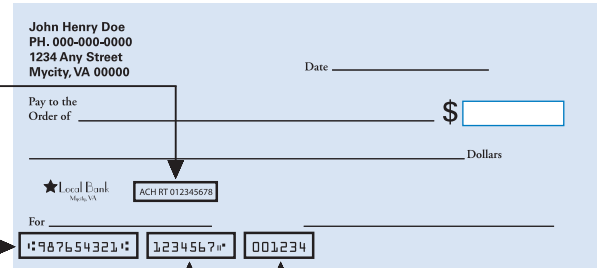

To find the routing and account numbers

For checks with an ACH RT (Automated Clearing House Routing) number, please use this routing number.

For all other checks, use the nine-character routing number, which appears between the **Ⓜ** symbols, usually at the bottom left corner of the check.

The account number is up to 17 characters long and appears next to the **Ⓜ** symbol at the bottom of the check and usually to the right of the bank routing number.



Do not use your check number, usually located here.
